### 1. Welcome & Refresher on Categories

- Key questions review
- Vision for the replacement bond review
- Goals
- Project development
  - Capital lists, staff plans, stakeholder input
  - Sorting session and prioritized; sharing what is most important projects
  - Used a variety of methods to obtain costs of projects
- Proposed categories for work session
  - Five major categories; added implementation category (e.g. costs of selling bonds, staffing to carry out many projects)

### 2. Category Exercise

- Five stations with a bond category for each station; two groups, staff facilitated questions at each station
  - Environmental stewardship
  - Buildings and facilities
  - Accessible and safe
  - Connected trails
  - Recreation, parks, & community spaces
- BTF members identified what they considered most important project-wise in each category; asked to write down questions or comments in addition to rating projects

### 3. Group Discussion

- Sorting project was helpful in identifying projects; widely distributed
- Staff to review projects under the line in each category
- There was a modest level of interest in aquatic facility projects or multi-use facilities compared to other projects.
- Should highlight potential gym/fitness space at HMT complex (former administration building)
- Visioning session with Elsie Stuhr Center patrons on December 12; long-term visioning to address what patrons are interested in and share out info of any potential future plans

#### **5. Next Steps**

- Based on task force requests, THPRD to provide:

  - Update category information and send out to members ahead of time for review before next meeting
